



HOW TO – Open an Alternate Share Savings Account (Sub Account) within APCIRCUIT®

APCIRCUIT® PC Home Banking Service is the main system of our APCI eCU suite of electronic banking services. What was previously known as a Christmas Club and/or Vacation Club are now known as an Alternate Share 0002 or Alternate Share 0003. If you do not currently have an Alternate Share 0002 or 0003 Account, you have the option to open one yourself in APCIRCUIT.

1. Visit apcifcu.org and enter your APCIRCUIT ID and click “Continue.” Follow the prompts to complete the login process.



2. Click the “Services” tab and then select “Continue” after the Open Sub Account listing on the Services page.



- Under **Open Sub Account** select **“Alternate Shares”** and then click **“Submit.”** There is a limit of two Alternate Shares per account number. If you already have two Alternate Shares you will not see this option.




